Believed to be Horse Chestnut. We wish to gain approval to prune epicormic growth on the the main trunk. Ideally this would be to at least 4 metres high but possibly higher if agreed by the council. We have no intention or desire to prune the main canopy. We only want to prune epicormic growth from the main trunk which interferes with the fence and intrudes into the garden of 21 Barons Way; in line with normal practice of pruning trees which spread over property boundaries. Happy to discuss scope and limits of pruning with the council.
