- c) the parking of vehicles of site operatives and visitors
- d) loading and unloading of plant and materials
- e) storage of plant and materials used in constructing the development
- f) measures to control the emission of dust and dirt (including a scheme for wheel cleaning) during construction to ensure that the highway is kept free of mud, water, stones etc.
- g) a scheme for recycling/disposing of waste resulting from demolition and construction works
- h) measures to protect the trees and hedges to be retained on the application site during the duration of the construction works.
- i) measures to protect the wildlife habitats and wildlife corridors and avoid disturbing birds during the duration of the construction works.
- j) details of the erection and maintenance of security hoardings
- k) a programme of implementation for items (a) - (j) set out above.
